

ANIMAL SHELTER AND EAST TOUCHDOWN PLAZA - MONTHLY UPDATE

Timeline

- Notice to Proceed was issued June 4, 2010. Building Permit requirements resolved between June 4 and August 19. Notice to proceed date adjusted to August 23, 2010.
- Start of construction August 25, 2010.
- AT&T Cell Site PG&E power disconnect completed September 20, 2010 and AT&T telco disconnect completed October 15, 2010. This work delayed Geopier activities.
- Geopier installation started November 1, 2010 and completed on January 26, 2011.
- Contractor's schedule revision indicated a construction completion date of June 14, 2012 and building systems commissioning being completed by August 9, 2012.
- Engineering Staff sent Broward Builders, Inc. (BBI) a letter on March 20, 2012 regarding the project schedule. BBI responded to the letter and a meeting was held with the CEO of BBI on April 27, 2012 to discuss the proposed construction completion date. Based on the discussion the date of substantial completion is June 30, 2012 and the date of final completion is July 31, 2012 to include Commissioning of the Building Systems and Punch List.
- On July 6, 2012 Engineering Staff sent BBI a letter regarding another slip in the project schedule. A meeting was held with the CEO of BBI on July 11, 2012 to discuss the project schedule. Due to sustained issues with sub-contractor performance BBI was unable to meet substantial completion by June 30, 2012.
- BBI's schedule update issued on 7/19/2012 indicates substantial completion is August 15, 2012 and the date of final completion is September 10, 2012 to include Commissioning of the Building Systems and Punch List.
- BBI has continued to experience delays from sub-contractors and issues that have arisen during Commissioning of the building systems. The latest schedule is for Commissioning to be completed by 10/18/2012 with Substantial Completion by 10/26/12.
- Liquidated Damages have been held and will continue to be held until the project reaches Substantial Completion. To date \$107,500 in Liquidated Damages have been withheld.

Unfunded Items

Currently there is not enough funding allocated for all costs.

- AT&T Lease relocation costs Unknown (guesstimate approximately \$169K)
- Move-in costs \$4,500 (this will be covered from the existing project budget)

Outstanding Issues

- \$7.2M was needed from Bond Measure I originally received \$7,065,000 and was adjusted to \$7,099,340
- Sell of existing property \$800K to \$1.3M to be applied towards COP debt service
- Stop Waste grant (refund) after completion of project \$55,000
- PG&E Savings by Design after completion of project \$21,354
