Subject: Prioritization of City Council Referrals to Public Works Transportation

INTRODUCTION

The Public Works Transportation Division FY 2015 budget and work plan were adopted by Council in June 2014.<sup>1</sup> Since that time, Council referrals have been assigned to the Division or the Transportation Commission, which demand additional resources, or the reduction or delay in existing work plan priorities. This Worksession is an opportunity for Council to review and provide feedback on staff's recommended prioritization of these Council referrals to Public Works Transportation and the Transportation Commission.

CURRENT SITUATION AND ITS EFFECTS

According to the City Manager's Council Referrals tracking, there are 18 outstanding Council referrals assigned to Public Works Transportation and/or the Transportation Commission requesting information or action (see Attachment 1). These referrals were made between January 2012 and March 2015, and the FY 2015 work plan adopted in June 2014 can only include referrals made prior to submittal of that work plan. Referrals received since that time would need to replace other tasks on the original work plan, or be deferred to a subsequent work plan.

Transportation Division core services include, but are not limited to: traffic calming; managing on-street (meters) and off-street (garages/lots) parking; administering the RPP program; Safe Routes to School programs; supporting the Transportation Commission and Commission on Disability; implementing adopted plans such as the Pedestrian Master Plan and Bicycle Master Plan; and maintaining compliance with City and State required programs and permits. Other projects, including unanticipated activities, assignments, and Council referrals, are conducted in addition to these core services.

The Transportation Division has 17 full time equivalent positions, including vacancies that pose a temporary problem for delivery of core or baseline services. Transportation staff capacity is augmented through the use of consultants for preparation of plans and studies under staff supervision. Projects in this category include: residential preferential

parking (RPP) expansion; Downtown Berkeley Plaza and Transit Area; Hearst Complete Streets; Shattuck Reconfiguration; Center Street Garage replacement; Gilman Interchange; goBerkeley; Safe Routes to School projects; 4th Bore Mitigations on Tunnel and Ashby; Downtown Streets and Open Space Improvement Plan (SOSIP); parklet pilot; Bike Boulevard phase 2 implementation; curbside electric vehicle charging pilot; motorcycle parking policy; Berkeley High traffic safety plan; speed radar studies for enforcement; and AC Transit Line 51 coordination.

At its February 2015 meeting, the Transportation Commission discussed the Division work plan and Council referrals. They acknowledge that the volume of Council referrals exceeds staff capacity and funding levels, and that many referrals need to be put on hold, and support the staff prioritization plan for existing referrals, particularly with respect to deferred items. The Commission indicated the need for criteria, such as a safety goal, as the basis for prioritization of Council referrals and potential future work plan items. They recommended that the work plan provide for staff capacity to focus on collecting data and performing systematic analysis that can be used by Public Works and other departments to make informed decisions, rather than just responding to individual events in isolation and out of context with system-wide considerations. The Commission suggested that prioritization of work plan and referral items be linked to delivery of voter supported Measure BB and Measure M projects. This discussion led the Commission to adopt 3 motions:

1. Recommend that staff provide a prioritized list of referrals with clear prioritization criteria when reporting to Council on any referrals. The list should include estimated costs and staffing needs associated with each referral as well as active or inactive status of the referral. Recommend that Council consider prioritizing referrals and provide funding and staffing for high priority referrals based on information provided by staff. 2. Authorize Commissioner Bruzzone to attend the April 7, 2015 City Council meeting and speak on behalf of the Transportation Commission. (M/S Zander/Gerhardstein; Ayes: Roberts, McCaughrin, Lathbury, Zander, Thomas, Gerhardstein, Bruzzone; Noes: none; Abstain: none; Absent: Humbert)
3. The Commission supports staff development of a Transportation Safety Goal, which will support equity in implementation and maintain or improve mode share for non automobile modes of travel. ## BACKGROUND

The annual Transportation Division work plan assumes full utilization of staff resources and funding, including use of grants and consultants. The work plan is developed on the basis of Council adopted policies and plans such as the Pedestrian Master Plan and Bicycle Master Plan, as well as Council referrals from prior years. Adding Council

referrals or urgent projects to the work plan requires reprioritization of planned work by the Division. A clear understanding of Council preferences for prioritization and tracking of referrals by staff will assist staff in delivering the most important work products.

**ENVIRONMENTAL SUSTAINABILITY**

The Transportation Division work plan is full of projects and programs intended to improve public safety and sustainable modes of transportation. Thoughtful prioritization and allocation of resources to Council referrals will help us meet our sustainability goals.

**POSSIBLE FUTURE ACTION**

Public Works Transportation management's prioritization of Council referrals is intended to facilitate more effective use of limited Transportation staff resources. Council may wish to reprioritize the listed referrals, with consideration for available resources and relative cost of each referral. Future communication of the prioritized list and status of referrals will provide an additional decision making tool for the City Council.

**FISCAL IMPACTS OF POSSIBLE FUTURE ACTION**

Fiscal impacts will depend on the magnitude of revenue and/or expenditure impacts that changes in work plan priorities generate. Council confirmation of these referral priorities will inform the efficient use of staff resources and timely completion of high priority items, while selectively making feasible adjustments to the existing work plan.
