



SUPERSEDING INDICTMENT

The Grand Jury charges:

COUNT ONE: (18 U.S.C. § 2252(a)(4)(B) – Possession of Child Pornography)

On or about September 24, 2014, in the Northern District of California, the defendant,
KONRAD P. WOLFF,
did knowingly possess visual depictions of minors engaging in sexually explicit conduct that had been
mailed, or had been shipped or transported using any means or facility of interstate or foreign commerce
or in or affecting interstate or foreign commerce, and which were produced using materials which had
been mailed or shipped or transported, by any means, including by computer, specifically: videos and
image files depicting minor and prepubescent children engaging in sexually explicit conduct.

All in violation of Title 18, United States Code, Section 2252(a)(4)(B).

INDICTMENT

COUNT TWO: (18 U.S.C. § 2252(a)(2) – Receipt of Child Pornography)

Beginning on a date unknown, and continuing through at least September 24, 2014, in the Northern District of California and elsewhere, the defendant,

KONRAD P. WOLFF,

did knowingly and intentionally receive in interstate commerce, by means of a computer, certain visual depictions, the producing of which involved the use of one or more minors engaging in sexually explicit conduct, and which visual depictions were of such conduct, specifically: videos and image files depicting minor and prepubescent children engaging in sexually explicit conduct.

All in violation of Title 18, United States Code, Section 2252(a)(2).

FORFEITURE ALLEGATION: (18 U.S.C. §§ 2253(a)(1) and (a)(3) – Criminal Forfeiture)

Upon conviction of any of the offenses alleged in Count One or Count Two, the defendant shall forfeit to the United States, pursuant to Title 18, United States Code, Sections 2253(a)(1) and (a)(3), all visual depictions described in Title 18, United States Code, Section 2252, and all property, real or personal, used or intended to be used to commit or promote the commission of the offense of conviction, including but not limited to the following items that were seized on or about September 24-25, 2014:




