Quick follow up for First 8. As we move forward to reduce harm, may be useful to reflect and draw on this study's findings about successful <u>Alcohol Risk Management in College Settings</u>, including at UC Berkeley.

Key finding:

Legal (and I would add "social") enforcement of alcohol policies reduced likelihood of intoxication and did not displace drinking to other locations.

Subject: RECAP of F8 Meeting (8/31/16)

RECAP OF 8/31/16 F8 Meeting:

At the time of the 8/31/16 meeting, UCPD reported 10 incidents and 9 transports. We discussed the transport rates from this year vs. last and the areas of opportunity where we can improve. It was acknowledged that the 9/9-9/11 weekend and the following weekends are historically bad for transports - with week 6 (Homecoming) being a flashpoint.

Over the 8/26-8/28 weekend there were three incidents at the Greek theatre which drew large crowds of people from outside the community involving mixing alcohol and other substances. Bid Weekend in the Greek community (high risks across the country) may have also been a contributing factor in the number of transports.

IFC - Mitchell advised that members of the Greek community were and will continue to walk around observing parties. There were some chapters who were observed breaking rules which will be address with standard letters sent regarding expectations.

Perception of how party observation is received in the Greek community depends on the culture of the house. Those that want to show off how well they are following rules typically welcome the observation while those that want to remain under the radar tend to push back.

The goal is to get representation from all chapters (recognized and not) as observers to sell it as getting them closer to self-governance.

There were 6 events scheduled for the weekend of 9/9-9/11 (5 registered with BFD and one scheduled off site) as well as The Mad Decent Block Party at the Greek Theater which was expected to draw a large, mixed crowd. This concert resulted in a large number of transports last year and will, along with the other events, be discussed at the next scheduled F8 meeting. It was noted that large events at the Greek have almost doubled since last year and Andy will reach out to Cal Performances (Doug Warrick or Jill Schinberg) to request ongoing notification of upcoming large events/concerts.

UHS - Karen advised PartySafe will continue with its presence outside the theater and at key points between the Greek and Fraternity row handing out water and monitoring for people who may be in trouble. Karen advised PartySafe will also reach out to IFC/PHC groups for services opportunities to help provide food and water in the area.

Karen asked for a summary of what the Cal Greeks Alcohol Taskforce is doing. Dylan advised is it basically the same as GAMMA (i.e. water/snacks for parties) but they are currently working on a budget so it can be more sustainable.

The Happy Neighbors meeting attended by IFC, UHS, GCR, Conduct and students was pretty productive.

Mitchell distributed a complaints email address to neighbors which will go to VP of Standards for a quicker response on neighbor's concerns.

Ruben (GCR) provided a football briefing letting the community know what happens during this time. Karen advised this meeting produced the greatest number of student participants who were able to meet their adjacent neighbors.

Student Conduct – advised that they are ready to handle cases but no organizations or students have currently requested immunity under the responsible bystander policy. They will continue to work on internal operations.

BFD - Tony Yuen attended the meeting and provided a new reporting spreadsheet format from the city which can include a column that indicates where students were prior to transport. He advised he can customize it to provide more useful information. Tony will work with Andy to finalize the format.

RSSP - will implement Security Monitor training to develop how to build real time feedback on what's observed at the door.

ASUC – want more partnership in knowing who sober party monitors are at parties. Working on more support organization.

BPD – not present at meeting.

NEXT STEPS:

Mitchell will reach out to David regarding water station

ASUC – looking into helping Mitchell out with this Shallon – will talk with Tinney regarding ABC enforcement. Andy/Tony – will finalize BFD report formats.

Subject: RECAP of F8 Meeting (8/31/16)

RECAP OF 8/31/16 F8 Meeting:

At the time of the 8/31/16 meeting, UCPD reported 10 incidents and 9 transports. We discussed the transport rates from this year vs. last and the areas of opportunity where we can improve. It was acknowledged that the 9/9-9/11 weekend and the following weekends are historically bad for transports - with week 6 (Homecoming) being a flashpoint.

Over the 8/26-8/28 weekend there were three incidents at the Greek theatre which drew large crowds of people from outside the community involving mixing alcohol and other substances. Bid Weekend in the Greek community (high risks across the country) may have also been a contributing factor in the number of transports.

IFC - Mitchell advised that members of the Greek community were and will continue to walk around observing parties. There were some chapters who were observed breaking rules which will be address with standard letters sent regarding expectations.

Perception of how party observation is received in the Greek community depends on the culture of the house. Those that want to show off how well they are following rules typically welcome the observation while those that want to remain under the radar tend to push back.

The goal is to get representation from all chapters (recognized and not) as observers to sell it as getting them closer to self-governance.

There were 6 events scheduled for the weekend of 9/9-9/11 (5 registered with BFD and one scheduled off site) as well as The Mad Decent Block Party at the Greek Theater which was expected to draw a large, mixed crowd. This concert resulted in a large number of transports last year and will, along with the other events, be discussed at the next scheduled F8 meeting. It was noted that large events at the Greek have almost doubled since last year and Andy will reach out to Cal Performances (Doug Warrick or Jill Schinberg) to request ongoing notification of upcoming large events/concerts.

UHS - Karen advised PartySafe will continue with its presence outside the theater and at key points between the Greek and Fraternity row handing out water and monitoring for people who may be in trouble. Karen advised PartySafe will also reach out to IFC/PHC groups for services opportunities to help provide food and water in the area.

Karen asked for a summary of what the Cal Greeks Alcohol Taskforce is doing. Dylan advised is it basically the same as GAMMA (i.e. water/snacks for parties) but they are currently working on a budget so it can be more sustainable.

The Happy Neighbors meeting attended by IFC, UHS, GCR, Conduct and students was pretty productive.

Mitchell distributed a complaints email address to neighbors which will go to VP of Standards for a quicker response on neighbor's concerns.

Ruben (GCR) provided a football briefing letting the community know what happens during this time. Karen advised this meeting produced the greatest number of student participants who were able to meet their adjacent neighbors.

Student Conduct – advised that they are ready to handle cases but no organizations or students have currently requested immunity under the responsible bystander policy. They will continue to work on internal operations.

BFD - Tony Yuen attended the meeting and provided a new reporting spreadsheet format from the city which can include a column that indicates where students were prior to transport. He advised he can customize it to provide more useful information. Tony will work with Andy to finalize the format.

RSSP - will implement Security Monitor training to develop how to build real time feedback on what's observed at the door.

ASUC – want more partnership in knowing who sober party monitors are at parties. Working on more support organization.

BPD – not present at meeting.

NEXT STEPS:

Mitchell will reach out to David regarding water station ASUC – looking into helping Mitchell out with this Shallon – will talk with Tinney regarding ABC enforcement. Andy/Tony – will finalize BFD report formats.
