Subject: Discussion and Direction Regarding Potential Ballot Measures for the

November 6, 2018 General Municipal Election

#### RECOMMENDATION

Discuss results of the first community survey and provide direction to the City Manager about whether to conduct a second community survey and, if so, what to include in that survey.

### SUMMARY

On February 27, Council discussed several possible ballot measures for the November 2018 election. Council asked staff to undertake a community survey and include questions about the following possible measures: a one-half percent sales tax for community safety; a parcel tax for homeless services – separately testing both a 12 year and a permanent tax; a \$50 million affordable housing bond; a \$100 million affordable housing bond; and a tiered increase of property transfer taxes with the revenues going to a variety of strategies for affordable housing.

Lake Research Partners conducted the survey from March 12 through March 15. The poll closed after the filing deadline for this report. The final questionnaire is attached, and a summary of the survey results will be provided to Council in a supplemental report.

### FISCAL IMPACTS OF RECOMMENDATION

The cost of the second community survey is expected to cost \$25,965.

The table below shows the year-by-year costs for elections since 2008. The dramatic cost increase that occurred in 2012 and 2014 is due primarily to general year-over-year increases, and the addition of two more required languages (Vietnamese and Tagalog). The cost increase in 2016 is due to a surcharge from the Registrar of Voters to pay for replacement of the voting machines in 2020 or 2022. This surcharge will continue for several more election cycles.

### **CURRENT SITUATION AND ITS EFFECTS**

The purpose of this report is to provide an opportunity for the Council to discuss the results of the first Community Survey, for Council to provide direction about whether to conduct a second community survey to test ballot measure language and, if so, for Council to determine what topics to include in that survey.

On February 27, 2018 the City Council discussed possible ballot measures for the November 2018 ballot and provided direction about what to include in a community survey. The intent of the survey was to better understand residents' priorities and their interest in paying for various improvements and services while also gauging their interest in enacting various other taxes.

## **Second Survey**

If the Council decides to move forward with a second survey at this meeting, the survey would be conducted in early April in order to provide the results at the May 15, 2018 meeting. Actual ballot language would still need to be developed by staff for consideration by the Council in June, in order to meet the deadlines in the Elections Code.

<u>Survey Length</u>: A second survey was included in the original scope of work for Lake Research Partners. In previous years, the City has done two surveys: the first is used to get a broad sense of community preferences and to test potential ballot measures. The second survey is approximately is used to test a more narrow set of specific ballot measures or to test the proposed measures in more nuanced ways. The sample size of likely voters for each of the polls includes at least 500 respondents, which allows for more complex testing of ballot measures than a 400-respondent sample.

<u>Context</u>: The first survey assessed likely voters in the context of several local or county measures. The second survey can include information about the other proposed sales tax measures that have a strong likelihood of being on the Fall 2018 ballot.

<u>Depth</u>: Testing a smaller number of ballot measures will provide time for follow-up questions, allowing for a deeper analysis of the results. For example, there may be time to assess how residents respond to supportive and opposing arguments that they may

hear in the months preceding the election. These messages may be specifically about local measures, or be more general arguments about State and County revenue measures on the November ballot.

<u>Language</u>: In order to accurately assess how residents will respond to the revenue measures once they are on the ballot, the Council may want to direct staff to test actual ballot measure language.

## Ballot Measure Development Next Steps

In order to meet the deadlines set by the Elections Code to place items on the November ballot, the following timeline has been developed for the Council's consideration:

Continue discussions of funding needs, but do not conduct a survey at this time.
